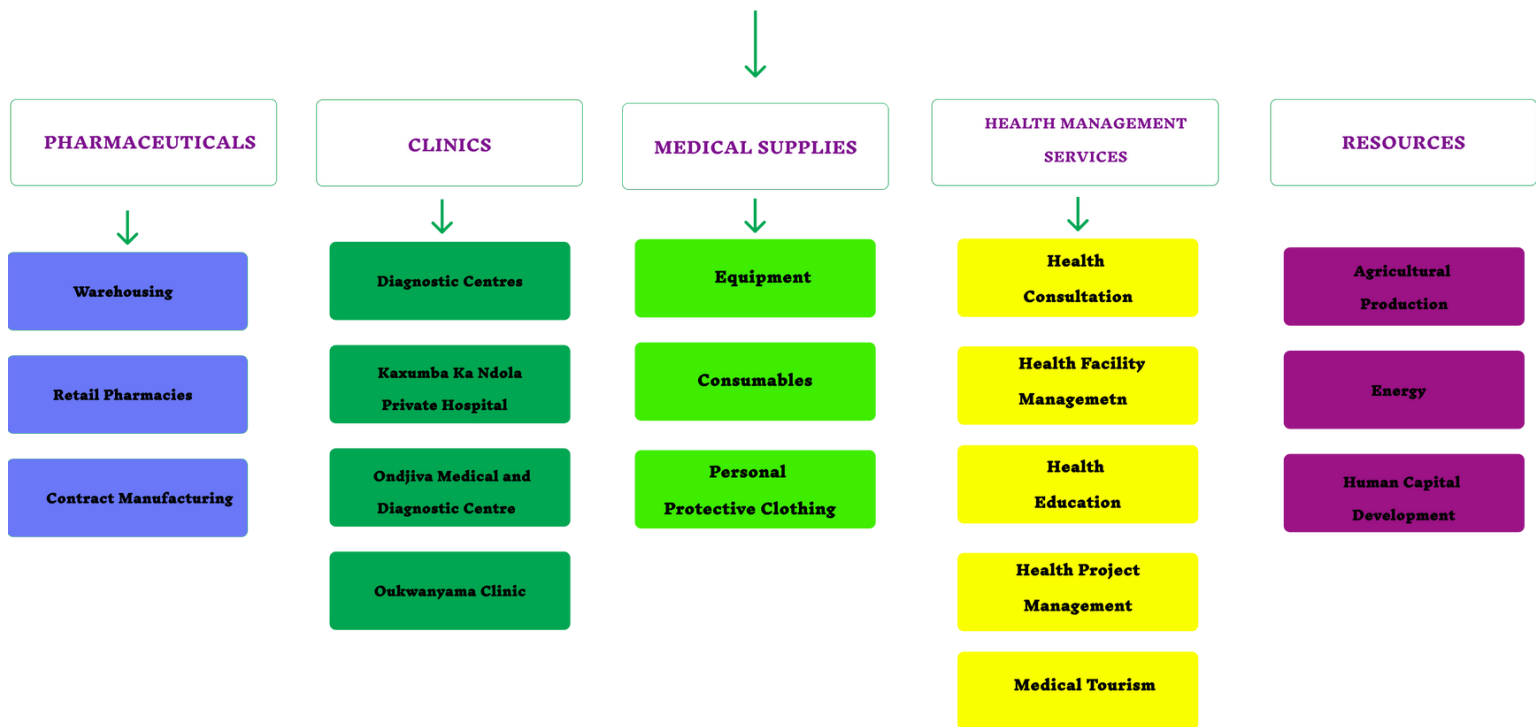
Company Structure
